MAKING YOUR RESERVATION

The following information will help you book your BTTF Cruise Adventure properly and with minimal effort through our exclusive official planning agents at Cruise Trek. Please read all the information carefully before completing the reservation form. You will be receiving periodic Flux Updates, which will keep you informed of all the breaking news for your BTTF Cruise Adventure. Several weeks prior to sailing, all your electronic cruise documents and tickets will become accessible to you for review & printout through the issuance of your own private booking number via the cruise line's own web site at royalcaribbean.com. In this online package will be a guide that includes information on what to pack, a list of available shore excursions with prices, phone numbers for the ship, and much more. We will also send you a "document letter" which will explain the pertinent details and exactly how to log in and start your account with Royal Caribbean. As is the case with most celebrity/fan events, we may not know until much closer to sailing time exactly which or how many "special guests" will eventually end up being able to join us. All celebrity guest confirmations listed on our official web site or any other advertising or promotional materials of ours were current at the time they were last updated, but changes may of course occur. As is the case with any fan event or convention, all celebrity appearances are subject to professional commitments & health or family issues, which may force unexpected changes or cancellations, so please check the web site regularly at BTTFcruise.com for the most up to date info. As a not-for-profit fan managed event, it is always our goal to bring you the best event possible, and as a general rule, the more fans who book the cruise, the more celebrity guests we are able to bring along on the voyage, and the more funds raised to help support our charitable beneficiaries! Booking and/or sending deposit constitutes understanding and acceptance of all terms and conditions of the applicable cruise line and BTTF Cruise & Cruise Trek. HOW TO BOOK: SELECT PLAN I, II, III, IV, or V

Cabin prices vary by the category and type of accommodations you select, as detailed on the accompanying Booking Reservation Sheet. There are Inside Cabins with NO window. There are Outside Cabins WITH a window. There are Outside Cabins with both a window & a BALCONY, and the balcony may look out onto the ocean, or onto an onboard plaza. The sizes of these cabins are very similar only the location may be different. All of them have private bathrooms with shower, sink & toilet. All cabins have two twin beds that can be moved together & locked to become a king bed, and some cabins can accommodate a third or fourth passenger either in a convertible sofa bed or in bunks that easily fold out from the wall when needed. Although not in our discounted room block, there are also larger deluxe suites that sleep up to 8 that we can price for you on a case-by-case basis, but at **considerably** higher rates, based on availability.

(I) SINGLE OCCUPANCY: This is for those of you who wish to occupy a full sized cabin alone. Pricing is significantly higher as the cruise line charges us a full 200% of the Base & NCF portions of their fare, which we unfortunately must pass along in our overall event membership pricing. Singles are very limited in supply.

(II) TWO PERSONS SHARING SAME CABIN: Standard double occupancy means two passengers share one cabin.

(III) TRIPLE OCCUPANCY: Some cabins have a sofa bed or fold out bunk for a third passenger to share at a discount.

(IV) QUAD OCCUPANCY Some cabins have a sofa bed & or fold out bunks for a third & fourth passenger at a discount.

(V) FLUX SHARE (FS) FARES: This plan is for passengers who are sailing with our group by themselves and wish to share a cabin with another single traveler within our own group. Specify the FS category of your choice and indicate the occupancy you desire. **Be sure to check the box that says Flux Share.** You will be matched with members of the same sex. Flux Share cabin assignments will be done at the time of issuance only and are subject to change. Smoking is allowed only in designated areas on board the ship, and is NOT allowed in cabins. Fees will be assessed by the ship if a passenger violates the stated policy. FS cabins are non smoking no matter. We will try to match you with fans of similar age whenever possible. Most fans are understanding and cooperative. FS fares are not applicable for children. These shares are on a request basis only.

CHILDREN'S DISCOUNT: Although the cruise line does not offer us any sort of children's discount off the Base & NCF portions of their fare, we will be offering, upon request, a \$100 per child discount off of **our** overall event membership pricing, **providing that they travel as 3rd or 4th passengers added to their parent(s) otherwise Double cabin.** **If you prefer a neighboring or connecting cabin for the kids, they will be charged at the full rate for that cabin.**

PHYSICALLY CHALLENGED CABINS: Although this ship and the country where it is registered are **not** governed by the US government's ADA, the cruise line has still made considerable provisions for accessibility, with elevator access to all decks, wide hallways with ramps where appropriate, and a limited number of cabins specially modified for wheelchair users. Boarding at some ports may require you and/or your wheelchair/scooter being carried or assisted up or down some steps, ship's crew are often happy to offer their help with this. On this sailing there are currently no scheduled tender boat stops, all of our scheduled ports now have dock facilities. (next page)

PORT CHARGES, TAXES & GRATUITIES: Port charges and taxes are additional. They are \$120 per person. Gratuities for your service staff are automatically added to your onboard account and amount to \$12 per day (that's \$96 for the full week) per person & can be adjusted up or down for superior or sub-par service. These amounts may be subject to change by the cruise line.

PAYMENT INFORMATION: There is a foreign booking charge of \$50 per foreign residence or APO address (\$30 per Canadian residence). Payments may be made by check, money order, or major credit card—Visa, Master Card, American Express, and Discover. Checks are to be made payable to Cruise Trek, in US dollars only, and drawn on a US bank. Sorry, no exceptions. There is a \$50 charge for returned checks. Any fees or charges related to check or wire payments will be charged back to your invoice. **PERSONAL PAYMENT PLAN:** For your convenience, we will be offering a payment plan with no service charge. To calculate your payments, simply deduct your deposit from your total amount due, and then divide the balance by the number of months remaining before the full payment date. The payment plan is flexible. For instance, you may either double or triple up on payments or skip a few months. Or you may devise your own plan. If you would like to take advantage of our "Auto Pay Plan" simply fill out the payment coupons (they will be sent with your original invoice) and return them to the Cruise Trek office with the plan of your choice. We will process these each month. All pricing is in US Dollars. **FULL AND FINAL PAYMENT IS DUE BY 1 AUGUST 2015.** You MAY still book after these dates—but pricing may be increased and/or availability may be **VERY** limited if not **COMPLETELY SOLD OUT!** Pricing is subject to change prior to receipt of deposit only.

CANCELLATIONS, REFUNDS, INSURANCE, OTHER DISCLAIMERS AND CHANGES: After Booking - If you should cancel your reservation a \$250 cancel fee applies. After 1 August 2015 the cancellation fee increases to \$500. Cancellations after 1 September 2015 forfeit 100 % of your booking. If you book the cruise lines pre or post tours/hotels and have to cancel – additional cancel fees will apply to those packages. Also, after the full payment due date, all invoices will be subject to a charge of at least \$100 or more per person for any changes. To protect against cancellation penalties, Trip & Cancellation Interruption Insurance is available and strongly recommended. As a requirement of the BTTF Cruise Program, the signed Insurance waiver (which will accompany your invoice) is due in the Cruise Trek office upon receipt of your invoice and no later than the full payment due date. Travel documents will not be released and your booking is subject to cancellation unless we receive this waiver. Cruise Trek, The BTTF Cruise, and the cruise line all reserve the right to change group event schedules, programs and structure and claim no responsibility to cruise line changes or conditions. We reserve the right at our discretion to refuse service and/or entry to the events to anyone who, in our opinion, is not suitable, safe or in line with our mission to provide a positive, family, friendly environment while boldly exploring new cultures and different parts of our world. We may also refuse service to those who are not agreeable to the structure, terms and conditions either implied or stated as they benefit the mission and the "whole." In sending your deposit you then agree to all such terms, conditions and structures.

IDENTIFICATION REQUIREMENTS: As this particular cruise sails round trip from a USA owned port, passports are not required for USA citizens, but are still strongly recommended in case you have to fly directly back to the USA from one of the islands in the event of medical emergency or missing the ship. USA citizens sailing WITHOUT a passport MUST carry an ORIGINAL or a CERTIFIED COPY WITH RAISED SEAL of their birth certificate, as well as an official photo ID (such as drivers licence) and green card holders must also bring their green card. Citizens of other countries please check on any specific requirements that may be needed at any individual port of call other than for normal entry into the USA to board the ship. Please make sure that your passport is valid for at least 6 months after completion of your cruise or trip. All travel documents, such as passports, visas, proof of citizenship, etc., required for embarkation and debarkation at the ports of call and reentry into your country of residence, are the responsibility of the passenger. Your proof of citizenship must be presented prior to boarding the ship. You may be denied boarding without proper identification and cancellation fees applied.

PRE & POST CRUISE HOTELS, TOURS & EVENTS: Pre or post cruise hotel tour programs in Fort Lauderdale may be available from the cruise line and Cruise Trek can reserve same for you if desired. Cruise Trek can also arrange for different hotels and sometimes at lower cost, which CT can help and or direct you as well. Shore excursions at each port of call are optional & NOT included in the cruise fare. Most ports have something of interest available as simple "make your own" walking tours and/or short taxi/bus tours. Lengthier professional shore excursions will be available as an option on board sold by the ship's own tour office. We plan to have a "bon voyage" party landside in Fort Lauderdale, Florida in conjunction with our friends who run the annual Fort Lauderdale International Film Festival, whose dates traditionally coincide with ours. This party will be covered in more detail on the BTTF Cruise web site as the date draws closer, including a host hotel and group rate that night in Fort Lauderdale. You may want to consider this when planning your own travel, in case you wish to attend the Bon Voyage Night in addition to the cruise.

AIRFARE: Online travel sites such as Travelocity.com, Expedia.com, or Travelzoo.com are excellent resources. If you have a good air agent - they are invaluable - ask him or her to check consolidator fares. Do not hesitate to call the Cruise Trek office for more clarification on airfares if needed. However, please know CT does not ticket airfare - we can only help direct you or have the cruise line arrange same for you. There is a \$75 CT fee per person for air assistance.
